2022/0689/FUL 35A Main Street. Replacement of existing wood casement windows with white woodgrain Residence 7 pvcu windows. No objections. Granted 12/09/22

2022/0767/CAT Hollygate House, 6 Holygate Road. T1 - Horse Chestnut - Fell -. T2 - Common Lime - Raise crown to 3.5m above ground level to allow great lateral light infiltration to garden. T3 Pink Horse Chestnut - Raise crown to 2.5m above ground level to allow greater light infiltration to seating area beneath. No objections It is important that the diseased tree is removed quickly before spreading to other trees. Granted 15/08/22
