## Finance/Legal

The Playing Field Annual Accounts accompany this report.

The Financial Return to The Charity Commission was submitted in April 2023.

We need to raise £1500+ simply to cover the annual running costs which include insurance, utility bills, grass cutting, business rates, play area maintenance repairs etc. ( See accompanying Annual Accounts)

# Childrens Play Area .Awaiting ROSPA visit for 2023 .

The trustees have organised for a joint meeting with The ROSPA Inspector to take place on his next visit.

The trustees have been advised by ROSPA that the play equipment is likely to need to be decommissioned before the end of its operating life and sadly that point is getting nearer. We plan to take further advice from the next inspection due soon and will advise villagers of our decision as soon as we can. Going forward the trustees are keen to ensure the village playing field is accessible and inclusive for all villagers and will be happy to take feedback for new ideas obviously mindful of the financial constraints we are operating under as a very small charity

#### Care and Maintenance of Field and wooded area

Normal grass cutting and de thatching regime has recommenced. Rewilding of the periphery of the field continues to be encouraged. The saplings acquired from The Woodland Trust are doing well as is the Jubilee Horse Chestnut sapling. A further volunteering day to be planned to include further clearing of the wooded area.

# AshTrees/ Ash Dieback Disease

Following on from conversations and advice sought from a local arborist and Rutland County Council we submitted a planning application for the proposed works to the affected trees involving either pollarding or felling.

We have now received planning permission for the required work to proceed with certain restrictions to nesting birds and bats and with the premise that for each tree felled a new sapling will be planted. The work is therefore planned for early Autumn.

Football Pitch/Nets. New nets acquired and in place.

**Fencing/ Bushes** Cutting back of bushes and new fencing is required between the play area and top road on the side of Green Lane. Plan is in hand to carry out the work involved.

**Dog poo bins** proving to be very successful. Thanks go to Karen and Nicky for the regular emptying of them.
